MARKING GUIDELINES

A1 RATING - should be awarded when the trainee is **POOR** and has a vast area for improvement. (It is not unusual for those on their first assessment/year on the scheme to be awarded marks in this area).

A2 RATING - should be awarded when the trainee is **FAIR** and this should indicate some development areas that still require to be addressed.

A3 RATING - should be awarded when the trainee is **GOOD** and where you are satisfied that the trainee meets the requirements fully and is a standard performer.

A4 RATING - should be awarded when the trainee is **VERY GOOD** and would indicate that the trainee had exceeded the standard performance.
